**Subject: Urgent Representation seeking Immediate Legal Action, Compensation, Medical Support and Rehabilitation for Victim — Smt. Kamla Devi (aged 60 years), Brutally Assaulted, Bodily Mutilated, and Robbed in Ganga ji Ki Kothi Village, Gangapur City.**

Respected Sir/ Madam,

At the outset let me state that the present letter is no emanating from reading of the press reports in Delhi. Contrarily and incidentally I was in Jaipur on 10th October, when due to fortuitous circumstances Mr. Jagmohan Raigar (cell 8107356117) interacted and informed me of the horrendous criminal act of chopping of two lower limbs of Mrs. Kamala Devi. On seeing the photograph, a several cold shivers ran down my spine and they haven't ceased since.

I work for the Society of Digital Entrepreneurs (SODES), an organization committed to providing free legal consultancy and assistance to underserved and marginalized individuals, and it wishes to draw your urgent attention to a horrifying incident that occurred in Ganga ji Ki Kothi village, under the Kotwali Police Station area of Gangapur City, District Sawai Madhopur, on Tuesday. Smt. Kamla Devi, aged around 60 years, resident of Seetod village, Bamanwas, was lured away under the pretext of being given labour work. Subsequently, she was subjected to a brutal and inhuman assault wherein both her legs were cut off, and her silver anklets were forcibly taken. This ghastly act constitutes not only attempt to murder and robbery, but also a severe offence against the dignity and safety of women, warranting immediate and coordinated action by the district administration, police, and legal aid authorities.

After studying the case, it is incumbent upon all of us in civilised society and particularly the civil and police administration that the unfortunate victim receives full justice and towards meeting this goal, the following steps are necessary :

**1. Legal Action and Investigation:** FIR and expeditious investigation under appropriate sections of the BNSS and other criminal and civil Acts- — It is understood that the police was prompt in arresting the accused within four hours. It should be ensured that the

relevant sections of BNSS viz Attempt to Murder), Grievous Hurt), Robbery), Assault or Use of Criminal Force to Woman), Common Intention etc. should be applied. If any caste-based element is involved, please also examine applicability of provisions under the SC/ST (Prevention of Atrocities) Act, 1989. The periodic progress should be reported to the District Collector and State Women Commission.

**2. Medical Treatment and Rehabilitation:** The District and State Administration should ensure comprehensive medical care for Smt. Kamla Devi at government expense, including providing for surgical treatment, prosthetic limbs, physiotherapy, and long-term rehabilitation. A medical social worker should be appointed to coordinate between hospital and administration for continuity of care also provide nutritional supplements, assistive devices, and home-based nursing support post-discharge. She should be provided psychological counselling and trauma support, through the District Psychiatric Unit or One Stop Centre.

**3. Financial Relief and Compensation:** Please grant interim compensation immediately under the Rajasthan Victim Compensation Scheme, 2011 and Sakhi One Stop Centre fund provisions. Besides, also facilitate sanction of permanent disability pension, inclusion under Social Security Pension Schemes and grant of fund under Chief Minister's Relief Fund. She is also a fit case to sanction ex-gratia support under the Prime Minister's National Relief Fund (PMNRF) and Nirbhaya Fund constituted by the State Government.

**4. Legal Aid and Protection:** Since she is from SC community as well as woman (senior citizen), the District Legal Aid Society (DLSA) should immediately appoint a Legal Aid Counsel to represent the victim's case, assist in proper filing of FIR, compensation filing, and continuous presence in court proceedings. Additionally, if need please ensure police protection to the victim and her family to prevent intimidation or coercion.

**5. Social Security and Livelihood Restoration:** If not already provided, victim should be included for coverage under PM Awas Yojana (Gramin) and ration entitlements under NFSA. Depending on the family condition, livelihood assistance or employment for a family member under MGNREGA or State Livelihood Mission should be considered. If needed she should be provided temporary shelter and social welfare support through the District Social Welfare Office until full rehabilitation.

**6. Monitoring and Accountability:** A District-Level Coordination Committee chaired by the District Collector should be constituted if not existing, with representation from Police, DLSA, Women & Child Development Department, Health Department, and local elected representatives. The Committee may review the case fortnightly and submit progress updates to the State Women Commission and Home Department.

We appeal for the administration to treat this case as a precedent for showing systemic response ensuring every such survivor receives justice, dignity, and holistic care on a continuum paradigm.

We therefore humbly request to take the abovementioned steps to address this horrendous crime and, extend immediate medical, financial, and legal support to Smt. Kamla Devi, and initiate coordinated administrative action to ensure that this survivor is not left unattended or voiceless in her pursuit of justice.
